Sociologist for IFFS

The Institute for Futures Studies (IFFS), Stockholm, is appointing a researcher to the project "Children's living conditions in a changing society: Socioeconomic and ethnic inequality." The project is concerned with social and ethnic inequalities among young people in present-day society, including intergenerational processes and segregation mechanisms, and is funded by a long-term grant by Forte (Swedish Research Council for Health, Working Life, and Welfare). It covers five major themes: educational inequality, child poverty, school and wellbeing, ethnic integration, and family structure. Around ten researchers at IFFS and Swedish Institute for Social Research at Stockholm University are currently engaged within the project, and much of the research involves international collaboration. IFFS, located in the heart of Stockholm city, hosts several related large-scale research projects, including projects on school and labour market segregation, employing and collaborating with internationally renowned scholars within sociology and related disciplines.

We seek an outstanding quantitative social scientist whose research interests and qualifications fall into one or more of the project themes. The successful candidate is expected to pursue their own research as well as collaborating with colleagues within the project and its international network. Fluency in English and experience in handling and analyzing micro-level data is a requirement, and knowledge of advanced statistical methods and proficiency in languages relevant for the work in the project (Swedish, German, Dutch) is a merit. A PhD is expected to be awarded by the time of appointment, but excellent applicants in the final stages of their PhD will also be considered.

We can offer a stimulating research environment, extraordinary data materials (including micro-level population register data and the <u>CILS4EU longitudinal study</u>), and competitive salaries. The position will initially be appointed for three years, with a possible extension, and should preferably be taken up at latest by September 2014. The position entails no teaching or supervision obligations, and project-related administrative chores of no more than 15% of the working time. The salary level depends on qualification, starting at 39,000 SEK a month (appr. 53,000 Euro or 72,000 USD per annum).

Applicants should submit, preferably by email:

- 1. A letter of application with a description of research interests (max 3 pages)
- 2. Curriculum Vitae, listing work experience and publications
- 3. Examples of published work or dissertation chapters (max 3 items)
- 4. Two references (name, position, email address)

Lives in Translation: Life Course Research and Social Policies

Although the overall conference theme will focus on social policy this year, we welcome conference submissions from all areas of longitudinal and life course studies: physical, psychological, social developmental and ageing processes and functioning within and across life course stages from infancy to old age; methods and findings of cohort studies; other sources of longitudinal data such as panel studies and record linkage; international comparisons; household, and income dynamics; intergenerational transfers and returns to learning; gene-environment interactions; 'mixed', and comparative methods; innovative methodology in design, measurement, data management, analysis and research practice (quantitative and qualitative). Senior Research Fellow and Senior Researcher (a recent Post Doc or equivalent) to INDIRECT-project

The research project "INDIRECT- Intergenerational Cumulative Disadvantage and Resource Compensation" funded by the European Research Council (ERC) is recruiting a Senior Research Fellow and a Senior Researcher (a recent Post Doc or equivalent).

The project studies the importance of resource compensation in socioeconomic inheritance. Often the loss of family resources does not show as a weaker attainment

of the children; the country differences in socioeconomic inheritance do not reflect their institutional differences as much as they are expected to. This can be explained by resource compensation. The lost capital (economic, human/cultural or social) may be replaced with the other types or with the resources of someone else (the new or extended family members or neighbors). European and other developed societies can be distinguished by their abilities to influence the compensation of the loss of parental resources rather than by their direct impact on inheritance. We study the compensation of lost parental resources in three contexts: 1) as life-course changes following losses, 2) as period changes creating losses and 3) as structural disadvantages associated with lost resources. The findings from high-quality Finnish register data are compared to the results from the German Socioeconomic Panel and the US-based Panel Study on Income Dynamics. Other country comparisons are conducted using the European Social Survey. The project combines three novel analytic approaches: sibling correlation methods, conditional multinomial (event history) models and sequence analysis.

The positions will be located at the Discipline of Sociology in the Department of Social Research, Faculty of Social Sciences, University of Turku. The key areas of research and teaching at the department are welfare research, the study of cultural interaction and social inequality, and comparative research.

Senior Research Fellow, 1.6.2014 (earliest) - 31.3.2019

The person to be chosen to the position has a key role in supporting the PI to fully carry out the project. The tasks include both research and research administration; the research fellow is expected to coordinate the three planned sub-studies and to participate in all of them. The position is intended for an experienced researcher who can be expected to acquire the qualifications of a full professor by the end of the project.

The person to be chosen to the position is expected to have a) a PhD in sociology or related field and the ability to do independent scholarly work, b) evidence of scholarly research work proven with a strong publication track record on topics related to the project, c) high quality methodological skills and previous experience on analyzing register data, Panel Study on Income Dynamics or German Socioeconomic Panel data and d) previous experience on working in high-quality research projects. A title of docent (dosenti) or an equivalent merit is considered an advantage.

The applicant to be chosen for the position is expected to begin working in the project latest in the beginning of September 2014. The contract will end by 31 March 2019 at the latest.

The application should include a motivation letter describing the applicant's own research interests in the field and how they are related to the project, an academic portfolio, a CV, a full list of publications and copies of five peer reviewed articles or chapters of books of the applicant that are related to the topic of the project. The salary is in accordance with the University salary system for teaching and research personnel level 6–7 where the work-specific salary component is between 3293.22 − 3799.56 €/month. The component based on personal performance adds a maximum of 46.3 % to this salary. There will be a trial period of 4 months.

Senior Researcher – a recent Post Doc or equivalent, 1.8.2014 – 31.7.2016

The person to be chosen to the position will work with the PI, the senior research fellow and a PhD student, conducting research under the sub-study of the project titled "Life-course events". The position is intended for a researcher who has defended her or his doctoral thesis relatively recently on a topic related to the project or is expected to do so within six months of the application deadline. The tasks include conducting research on the topics specified in the project plan.

The person to be chosen to the position is expected to have a) a PhD in sociology or in a field related to the topic (or close to acquiring such a degree, associated with strong practical research expertise in the field shown otherwise) and the ability to do independent scholarly work, b) some publications on the topics related to the project and c) previous experience on analyzing register data, Panel Study on Income Dynamics or German Socioeconomic Panel.

The applicant to be chosen for the position is expected to begin working in the project latest in the beginning of September 2014. The contract will last two years, with an option to a second two-year post doc period.

The application should include a motivation letter describing the applicant's own research interests in the field and how they are related to the project, an academic portfolio, a CV, a list of publications, a copy of the PhD thesis (or if not yet defended, the manuscript and a statement of the supervisor on the expected date of defending

the thesis) and two samples of writings (articles or manuscripts) on the topics related to the project. The appendices should follow the guidelines of the faculty, see http://www.utu.fi/en/units/soc/faculty/careers/Pages/home.aspx.

The salary is in accordance with the University salary system for teaching and research personnel levels 4 - 6 where the work specific salary component is between 2432.20–3293.22 €/month. The component based on personal performance adds a maximum of 46.3 % to this salary. There will be a trial period of 4 months.
